I understand that MAS 100 (Introduction to Massage) is a prerequisite to the Massage Therapy Program and must be completed prior to submitting this application or I must be registered for this course at the time of application submission. If currently enrolled in MAS 100, I must complete with a C or better to gain full acceptance into the program and register for MAS 110 (Fundamentals of Massage Therapy).

10. If I receive acceptance into the program, there will be additional program requirements to complete, including a [health examination record](#) and a [criminal background check](#).
